Dear Ms. Nisbet:

We are writing this letter to seek your help in obtaining numerous documents requested under the Freedom of Information Act (FOIA) from the Department of Health and Human Services and their subordinate organization the Food and Drug Administration.

In 2012, our small business fell victim to the misappropriation of our patented ideas, copyrights and trade secrets by members of the Food Defense Team of the Food and Drug Administration (FDA). Employees of the FDA Food Defense Team used our intellectual property to duplicate a number of our computer software tools. This resulted in the complete loss of our sales and we are now being forced out of business.

Since January of 2014, we have filed numerous requests for documents regarding our case pursuant to the FOIA. But our requests for the timely release of documents have been denied and we are being charged thousands of dollars in processing fees that we cannot afford to pay in order to obtain documents that are critical to our case.

Even more bothersome, we have been told by the FDA on several occasions that no documents responsive to our FOIA requests exist only to find out later that they do, in fact, exist. One example involves computer based sign in sheets used by the industry to access the software tools duplicated by the FDA based on the misappropriation of our intellectual property. Another example involves nearly 1000 e-mails sent by FDA employees within the government and the food industry that we believe may have "blacklisted" our small business.

Because our case involves such serious allegations of misconduct, we now conclude that the actions of the Department of Health and Human Services and the FDA are intentional and may have risen to the level of intentional obstruction of justice in our case. This is why we desperately need your help.

The Department of Health and Human Services and the FDA have repeatedly denied our requests for expedited processing. We have been told that there is no "compelling need" to release the documents we have requested in a timely fashion. In our case, there is an urgent need for us to obtain and disseminate the documents we have requested in order to quickly stop the Department of Health and Human Services and the FDA from forcing us out of business.

Moreover, the Department of Health and Human Services and the FDA have refused to waive processing fees in our case even though they are fully aware that we have no money to pay them because of the very actions they themselves have taken to force us out of business. So far, the Department of Health and Human Services has sent us bills for over \$8,545.46 before they will release the documents we must have to defend ourselves. The irony of the situation is extreme. Based on the very actions taken against us by the Department of Health and Human Services and the FDA to force us out of business we simply do not have the money we must have if we are to defend ourselves.


In The Law Bastiat writes,

“And when [law] has exceeded its proper functions, it has not done so merely in some inconsequential and debatable matters. The law has gone further than this; it has acted in direct opposition to its own purpose. The law has been used to destroy its own objective: It has been applied to annihilating the justice that it was supposed to maintain; to limiting and destroying rights which its real purpose was to respect. The law has placed the collective force at the disposal of the unscrupulous who wish, without risk, to exploit the person, liberty, and property of others. It has converted plunder into a right, in order to protect plunder. And it has converted lawful defense into a crime, in order to punish lawful defense.”

Attached is a matrix of the documents that we must have to defend ourselves from the actions that the Department of Health and Human Services and the FDA are taking to force our company out of business. We request your help in quickly obtaining these documents through the proper exercise of the FOIA so that they can be quickly disseminated to the appropriate Congressional authorities in time to stop the Department of Health and Human Services and the FDA before they completely destroy our lives. We are also concerned that relevant documents may be destroyed since there may be obstruction of justice involved in this matter.
