Subject: Violations of the Constitution by federal agencies and their contracted agents

Dear Senator Grassley:

The purpose of this letter is to assure that you, as Chairman of the Senate Judiciary Committee, are personally and fully aware of the information that we have been reporting to you for over the past three years involving serious matters falling under your immediate jurisdiction as the Chairman of the Senate Judiciary Committee.

Enclosed please find a copy of my CV that demonstrates I am well-qualified in the investigation of the serious matters I have tried and continue to try to bring to your personal attention. See Exhibit 1.

Since November 7, 2013, we have now sent you seven letters and copied you on another seven letters detailing widespread corruption in the U.S. Government. We are concerned that the important information we have been sending to you is not reaching your desk. Descriptions of this correspondence are affixed at Exhibit 2 and are already available to you from your Senate Judiciary Committee staff.

In sum, the correspondence we have sent to you demonstrates a widespread and systemic scheme by the U.S. Government to misappropriate valuable technologies from small businesses by the use of classified intelligence operations and other unlawful means. The scheme entails violations of section 901(a) of the Organized Crime Control Act of 1970 (P. L. 91-452, 84 Stat. 922) as codified at 18 U.S.C. ch. 96 as 18 U.S.C. §§ 1961-1968, otherwise known as the Racketeer Influenced and Corrupt Organizations Act or RICO.

Several federal agencies are involved in the corruption including the Department of Health and Human Services and the Food and Drug Administration, the Department of Energy and the National Nuclear Security Administration, several elements of the Department of Defense; the National Security Agency; the Federal Bureau of Investigation, and; the Department of Justice. The corruption also involves other elements of the Executive, Legislative and Judicial Branches of government.

The constitutional implications of the corruption include violations of Article I (patents and copyright clause); Article II (treaty provisions); Amendment IV (unlawful search and seizure) and Amendment V (takings clause) of the U.S. Constitution.

At Exhibit 3 you will find a letter to you and Representative Goodlatte dated May 15, 2016, that we believe is being stopped from reaching your desk. At Exhibit 4 you will find a May 11, 2015, letter to Mr. Christian Cook of the Senate Intelligence Committee that we have



already provided to the Committee staff but are concerned may not have been brought to your attention. We have reason to believe that this letter and other correspondence sent to you may not have reached your desk. The attachments to the letter at Exhibit 3 have already been provided to your Judiciary Committee staff. You can view the attachments to the letter at Exhibit 4 by contacting Mr. Christian Cook, Senior Policy Advisor to the Senate Select Committee on Intelligence.

Because of the extreme sensitivity of some of the attached documents we respectfully request that you limit the distribution of the documents to only other involved members and only trusted and authorized members of your staff. We also request that you personally discuss this letter and attachments with Representative Goodlatte, Representative Nunes, and Senator Burr to coordinate a unified House and Senate Judiciary and Intelligence Committees response to this most egregious matter.

Due to the seriousness of the matters we have reported to you we most respectfully request a brief letter from you confirming that you have personally received and considered the materials we have sent to you as referenced by this letter. Thank-you.

Post Script: September 26, 2016. Senator Grassley never responded to this letter or tens of tens of others like it. Just a few days ago when his staff was contacted by Mr. O'Keefe asking about the status of a response they asked him, "What's in it for us?" as the call ended. Mr. O'Keefe was angry at this type of treatment from a Senator who currently sits as the Chairman of the Judiciary Committee—one of the most important Committees in all of the Senate who is directly responsible for the actions of the Department of Justice and the Federal Bureau of Investigation.
