Subject: Unlawful U.S. Government Domestic Intelligence Collection Activities Are Driving Entrepreneurs and Small Start-ups Out of Business

Dear Messrs. Chairmen:

We are bringing to your attention a problem that is destroying entrepreneurship and the growth of small businesses across America. Below, we briefly summarize three typical examples of the growing U.S. Government trend to confiscate, without compensation, the property and livelihoods of American citizens without regard for the Constitution of the United of America.

Case number one involves an entrepreneur who developed a mobile drinking canteen for our soldiers that is now used to protect our troops on the battlefield from the effects of chemical, biological and nuclear weapons. After stealing the technology, the U.S. Army duplicated work already done by the entrepreneur driving him out of business. This resulted in over a three-year delay in getting the protective gear into the hands of our troops fighting in the Iraq War. As a result, tens of thousands of veterans are now suffering from Gulf War Syndrome, a debilitating disease that resulted from their unnecessary exposure to toxic materials.

Case number two involves the safety of the American food supply and the U.S. Food and Drug Administration (FDA). In this instance, the FDA stole the technology developed by the entrepreneur that projects the future possibility of food-borne illnesses in order to prevent them. The U.S. Government (FDA and the Department of Defense) proceeded to duplicate the small business's technology for use by the food industry. As a result, the FDA duplicated the technology and drove the small company out of business.

Case number three involves unlawful domestic intelligence collection activities by the National Security Agency (NSA), the Department of Defense (DOD) and the Department of Energy (DOE) targeting a small company to steal their technology. The technology is of great significance for intelligence collection, the precision delivery of weapons, nuclear weapons stockpile stewardship and stealth applications. As a result, the NSA, DOD and DOE duplicated the technology and drove the small company out of business.

We have conducted exhaustive investigations of each of the three cases above. The Commissioner of the FDA and the Secretary of Defense have openly acknowledged their guilt in

cases one and two above but have taken no actions to correct the problems. Case number three is hidden from public view by the U.S. Government through the unlawful application of the state secrets privilege. However, our investigation has uncovered irrefutable unclassified proof of the unlawful domestic intelligence collection activities where the U.S. Government has stolen, duplicated and used the small business's technology.

In each of the above cases, we presented evidence directly to Attorney General Lynch, Director Comey of the Federal Bureau of Investigation (FBI) and various U.S. Attorneys representing the various jurisdictions where the crimes against these three small companies were committed. In all three cases, the results of our exhaustive investigations and repeated requests for an investigation have been rebuffed. We have also been in communication with each of the individual Inspectors General of the Intelligence Community where the results of our exhaustive investigations and repeated requests for an investigation were rebuffed.

A copy of the letter we wrote to the Senate Select Committee on Intelligence staff on May 11, 2016, is attached. On June 27, 2016, we personally briefed the Senate Select Committee on Intelligence (SSCI) staff of the unlawful search and seizure aspects of these cases, especially as they relate to case number three above. At SSCI's request we have re-referred the matter back to the intelligence community. We are awaiting a response from the Inspector General for the Intelligence Community, writ large, Mr. McCullough.

Since the matters we are bringing to your attention represent such an egregious violation of the Constitution of the United States of America, we formally request that the General Accounting Office (GAO) be instructed to investigate in a timely fashion the activities of these and other federal agencies as they misappropriate and duplicate advanced technologies owned by U.S. citizens and the small businesses they operate in violation of the Constitution and laws of the United States.

Post Script September 26, 2016:

The Institute for Complexity Management (ICM) circulated this letter to each member of the Congressional delegations representing the owners of the three companies mentioned above. In spite of the overwhelming evidence that the lives of the three entrepreneurs and their families were being destroyed by the anticompetitive conduct of the U.S. Government, not a single Senator or Representative responsible for protecting the rights of their constituents would sign this letter.

Simply requesting a General Accounting Office (GAO) Investigation of an egregious matter such as this is not a difficult political task. In a representative democracy, when your elected representatives fail to represent their constituents it means that we are no longer a democracy. The following table more fully describes the failure of our elected representatives to represent their constituents. They have all failed to do the job that must be done to preserve the Constitutional rights of every American citizen. All of these politicians were elected to office based on their promises to support small business as one of the cornerstones of our economy. The ones that have declined to do their jobs are deceiving the American people.
